




Go to URL https://www.recognitiongapinc.com/recognitiongapinc/login.do and click on 'Activate Your Account'




2. Enter your Login ID (your 7-digit employee ID) and submit




If we have a unique email address for your record, then you will see the following message and receive a welcome email at the indicated email address. Skip to #7.




3. If your record does not have a unique email address, then you can continue and add contact method. Re-confirm your employee ID and submit



4. Provide an account recovery email address. This should be a personal email address or method of contact – something other than a Gap email address.




5. You should see a popup with the available contact methods for you. Select where you want to receive your activation email and click submit.




6. EMAIL CONTACT METHOD: If you are using email as your contact method, You will see this popup confirming a welcome email has been sent to the selected address.

If you are using text messaging as your contact method, you will receive an activation code via text. Proceed to #9 for the rest of the activation steps.



7. Go to your welcome email from Gap Inc. Global Recognition and click on the 'click here to activate your account' link.



8. That link will bring you back to the login page to set your password. This will be your password for the site and will be used for future logins.
